

# TERMS AND CONDITIONS

## Surfers Paradise Fest-Evil Online Pre-Purchase event tickets Prize Draw

### General

These terms and conditions apply to the Online Pre-Purchase of Surfers Paradise Fest-Evil Event Tickets (Night Stalker and Zombie Walker) prize draw, which is operated by **Surfers Paradise Alliance** ABN 19 097 068 285.

### Who can enter
